

## SAMUEL MÜELLER® CABINET WARRANTY CLAIM DETAILS

Samuel Müeller® guarantees to the original consumer purchaser that its cabinets are manufactured to be free from defects in materials and craftsmanship for five (5) years when used under normal residential conditions. Door hinges and drawer glides are warranted to be free from defects in materials and craftsmanship for the lifetime of the product under normal residential use. Proof of purchase is required for the warranty to be valid. This warranty applies only to the first owner and cannot be transferred. No representative or dealer is authorized to modify or extend this warranty.

This warranty does not cover replacements and/or corrections caused by misuse, improper maintenance, normal wear and tear, acts of nature, accidents, alterations, modifications, incorrect installation, poor storage or handling, exposure to environmental extremes, or any damage caused after the product leaves our facility. This warranty covers the product for normal interior use and does not cover the product when it has been moved from its original place of installation. The warranty is invalid if the product is used for applications other than their intended purpose. Labor costs of any kind are not covered.

At its discretion, Samuel Müeller® may choose to repair the affected component or replace it with a comparable item. Replacement parts may vary slightly from the originals due to changes in materials or availability. In some cases, the return of the defective product may be required for evaluation. While repair or replacement parts are provided at no charge, Samuel Müeller® will NOT cover the expenses related to shipping the replacement part to the customer, including any shipping charges, duties, or additional costs associated with the shipment of the replacement item. Replacements and/or corrections are at the sole discretion of Samuel Müeller® and will be limited in scope to a reasonable and equitable remedy.

Because wood is a natural material, variation in color, grain, and texture is normal and expected. These characteristics, along with natural changes that occur as wood ages, are not considered defects. Natural changes that occur include but are not limited to mellowing or darkening due to light, humidity, cleaners, smoke, or household conditions. Cabinets with hand-applied finishes, including glazes, may show subtle differences from piece to piece as hand applications naturally include variations and possible random drips or runs. Painted doors may also develop small joint lines over time as the wood expands and contracts. These traits are normal and not covered under warranty.

This warranty is valid only in the United States, Canada, and Mexico. Any implied warranties last only as long as the period allowed by law or the duration of this warranty, whichever is shorter. To the extent allowed by law, Samuel Müeller® is not responsible for special, incidental, or consequential damages. Some states do not allow certain limitations, so these exclusions may not apply to every consumer.
